1. Rs.210/- per set (to be deposited in the form of Banker's Cheque only drawn in favour of Sr.A.O.(CAU),MPPMCL, Jabalpur. The earnest money shall be accepted in cash only deposited in Sr.A.O. (CAU), MPPMCL, Jabalpur and original Money Receipt would be submitted along with tender document or in the form of Demand Draft in favour of Sr.A.O. (CAU), MPPMCL, Jabalpur. Any other Form of EMD will not be accepted. For Successful bidder deposited earnest money will be converted to Security deposit and will be released after completion of maintenance period.
2. Tender document will be issued to the eligible contractors on payment of its cost in the form of Banker's Cheque only, drawn in favour of Sr.A.O. (CAU), MPPMCL, Jabalpur. Rs. 100/- per set will be charged extra if the documents are desired by post.
